At the regional level, our members faced another challenge in advocating for land reform policies. They found that governmental and intergovernmental organisations like the Association of Southeast Asian Nations (ASEAN) and the South Asian Association for **Regional Cooperation** (SAARC) lacked the commitment to help realise people-centered land governance.
